CO and the Bde Comd paid informal visits to Coy dining halls during the Christmas Dinner, and wished everybody the compliments of the season. Concert given by members of "B" Coy held in "S" Coy dining hall during the evening. Received from Bde: 'British occupation of Khalkis'.
Feb 4th	"D" Coy celebrated Christmas Day. Received from Bde, and issued to Coys: Intentions for 5 Feb. Op Instr No 1 (G) 3 rd Leave Party of 40 OR and 4 Offrs (Major Paskins, Capt Matthew, Capt Layhe and Lt DC Smith) proceeded to Athens. 2 nd Leave Party of 40 OR and 4 Offrs returned from Athens.
Feb 5th	Patrols carried out as planned. For full report see evening Sitrep from Bde timed 051955B. To Coys: Intentions 6 Feb.

Feb 13th	Comd 12 Inf Bde visited CO during the morning. To Coys: Intelligence Sitrep.
Feb 14th	Div Comd visited Bn from $0900-1100$ hrs. From Bde: Report – Recce and Goodwill Mission on $11-13$ Feb. Details of Move.
Feb 15th	From Bde: Details of convoy for distribution of seed potatoes. To Coys: CO's memorandum on Training. Warning Order for Move.
Feb. 16th	Convoy under command Intelligence Sgt distributed seed potatoes as ordered, without incident. Move Order No 3(G) issued to Coys. 6 th Leave Party of 40 OR proceeded to Athens. 5 th Leave Party of 40 OR returned from Athens. Major WE Bruce-Jones and 101 OR joined Rear Party Italy on posting from No 1 IRTD.
Feb 17th	Admn Order No 1 issued to Coys. LF & ML(G) Intelligence Review received through Bde. Weather became very much colder throughout the day.
Feb 18th	Advance Party left for Athens, arriving at approx 1230 hrs. Coy representatives moved into their respective areas, and were accommodated for the night with 2 RF. At least one man to remain in each billet to be taken over in order that the civilian occupiers would not move back into the accommodation before the arrival of the Bn. Bn packed and ready to move early on 19 Feb. Advance Party from 6 BW arrived and accommodated in Bn area. Weather still cold. Major WE Bruce-Jones, Capt L Brown, Lt R Stephenson, Lt BN Willson, Lt JP Nichols, Lt EN Duke, Rev GHT Blake and 75 OR disembarked Greece and rejoined the Bn.
	ATHENS, GREECE
Feb 19th	Bn awaited arrival of 6 BW, then embussed in returning TCVs. Bn left Khalkis at 1345 hrs, arriving in Athens at approximately 1900 hrs. Ver cold journey through the mountains, with snow in places. Coys moved into Coy areas and settled in billets by 2000 hrs. Capt WA Baker (Rear Party Italy) admitted hospital (sick).
Feb 20th	Bn settled in. Weather still cold, with intermittent snow. Training policy: Confined to parades during the morning, so that the afternoons and evenings would be free for all personnel not on guard or essential duties.
Feb 21st	Coy PT parades in morning. Warning Order from Bde issued to Coys: Bn to be prepared to move at short notice. Bn may be required for

Feb 22nd	Coy Route Marches in morning. Weather very cold. Snowing practically all day.
Feb 23rd	RSM's Drill Parade. Weather still cold. Lt Col CGS McAlester MC posted to HQ Crete (promoted to Colonel). Major PM Plastow MC (No 2 I/c) assumed command of Bn. Lt DC Fuller ceased to be attached to Bde Battle School.
Feb 24th	PT parades in morning. Return of Accommodation Occupied in Athens forwarded to Bde. Weather improved during the day. Fine and sunny during the afternoon. Capt WA Baker discharged hospital, and rejoined Rear Party Italy. Copy of Text of Agreement signed on 12 Feb 45 between Greek Government and EAM received.
Feb 25th	1100: Church Parade held at Church of St Nicholas attended by all Offrs and 50 OR per Coy. Service conducted by Rev GHT Blake (Surreys). LF & ML(G) Intelligence Review received.
Feb 27th	Comd Offr and Adjutant attended conference at Bde HQ. 4 Div Op Order No 1 received.
Feb 28th	CO's conference held to discuss operational role in new area. Issued to Coys: Recce Party Orders. Op Order No 3(G). Orders fro Bde Comd's visit on 1 Mar. 5 OR proceeded to UK (LIAP). 10 Inf Bde OO No 4(G) received. 10 Inf Bde Op Adm Order No 6 (Greece) received.
