Issued to Coys: Tug-of-War Training Instructions. Talks by Bn 2 i/c on Postwar Economic Situation. Employment of Manpower(details). Received: Congratulatory Message from GREEKMIL. Bde Signal Instructions May 11th Cassino Day celebrated. Church Parade Service held in the morning. 1330: Sports Meeting Results: HQ Coy 16 points, "S" and "D" Coys 13 points, "C" Coy" 10 points, "A" Coy 5 points, "B" Coy nil points. The last event (Tug-of-War) decided the final result in favour of HQ Coy. 1st pull was very long - touch and go all the time. 2nd pull was short, and "A" Coy collapsed quickly. Prizes were presented by the Div Comd. An effigy of Hitler was paraded round the track in a jeep during the interval with an escort of motorcyclists, and a running commentary was given by Sgt Taylor. 1930: Bn Concert Party gave a new show which was excellently put over. 2130 Film Show 'The Lady of the Town' was followed by a singsong with drinks and cakes provided, and at 2345 the bonfire was lit and the effigy of Hitler was ceremoniously burnt to the war-cries of the "Devil" and his assistants (provided by "C" Coy). May 13th Church Parade with the Official Thanksgiving Service as approved by HM The King. 4 OR proceeded on LIAP 11. 1 Sgt and 3 OR proceeded to Glifadha Leave Camp. Capt. May 14th An accident occurred during the Battle Inoculation exercise for Greek National Guard Cadre Course.
